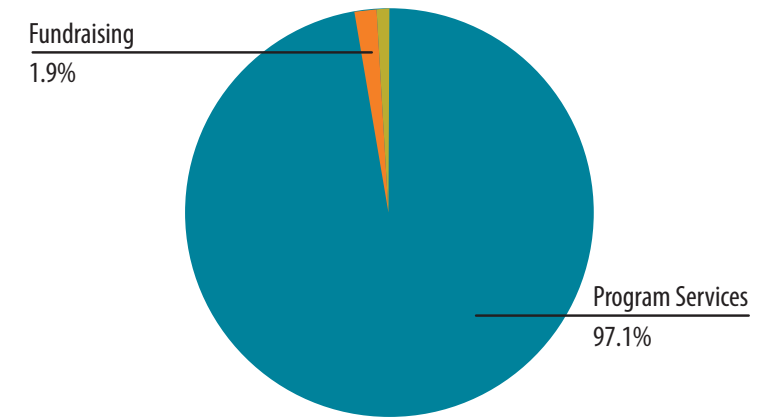

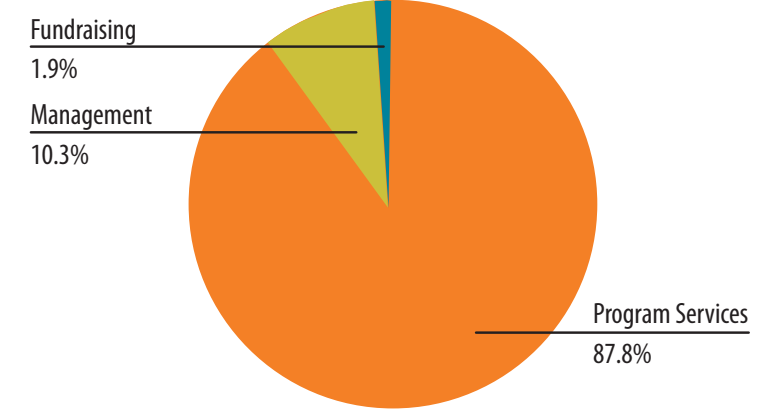
The purpose of this annual report is threefold:
