The Monarch School of New England is a day school that serves children and young adults with significant disabilities, ages 5 – 21.

WHY WE ARE UNIQUE

Ours is a nurturing environment. As a small school, we use an internal, collaborative model integrating education and therapy into a student's individualized program for the following:

- **Autism**
- **Multiple Disabilities** (i.e., physical disabilities, deaf-blindness, traumatic brain injury, hearing and vision impairment, developmental disabilities)
- **Emotionally Handicapped**

Our goal is to work with the student, address their educational challenges and in an appropriate timeframe, transition them back to the sending district – their home school.

OUR APPROACH

Rooted in the belief that each child deserves an environment in which they can flourish, the Monarch School of New England designs programs based on the individual needs and capabilities of each student. Students here are seen for their abilities, for their capacity to learn and to grow.

WHAT WE OFFER

Education

Students come to the Monarch School of New England with a variety of unique needs and abilities. Typically, there are no more than 7 students per classroom with a 1:1 ratio between the teacher and staff. Classrooms include students within a 4-year age range of each other. Our curriculum aligns with the New Hampshire Curriculum Frameworks, the Math and English/Language Arts Common Core State Standards and Maine Learning Results.

Related Services

Physical therapy, occupational therapy, speech/language and behavior are services we offer that help our students participate more fully and successfully in the learning process. Some of what we offer includes:

Pre-vocation and vocational programs including community based jobs; hippotherapy; therapeutic aquatics; adaptive skiing; music; art; gardening; and social skills training.
