Mission Statement

The Monarch School of New England supports individuals with special needs so they can realize their greatest potential. In this nurturing environment, a comprehensively trained staff works one-on-one with each individual, uniquely integrating both education and therapy, to ensure successful transitions to school and the community.



WHO WE ARE

The Monarch School of New England is a specialized day school, serving students with significant disabilities, ages 5–21. We work with students who have autism, developmental disabilities, physical disabilities, hearing or vision impairment, traumatic brain injury, emotional disturbance, speech/language disorders, sensory processing disorders, and rare genetic syndromes.

WHY WE ARE UNIQUE

Rooted in the belief that each child deserves an environment in which they can flourish, the Monarch School of New England designs programs based on the individual needs of each student. The collective expertise of our staff create individualized instruction which focuses on students' strengths. Students graduate with a resume of vocational, social and functional life skills to prepare them for adulthood.

OUR APPROACH

Founded on the principles of Applied Behavioral Analysis (ABA), we use a collaborative model, integrating education and therapies into a student's individualized program. Students at the Monarch School of New England participate in a variety of innovative and traditional programs, to help them realize their fullest potential. Our goal is to work with students, address their educational challenges, and in an appropriate time frame, transition them to their home school or on to work.

WHAT WE OFFER

Education—Curriculum is based on the *New Hampshire Curriculum Frameworks*, *Maine Learning Results* and *Common Core Standards*. With small class sizes, and a one-to-one ratio between staff and students, students receive the differentiated instruction and support they need to be successful. The Monarch School of New England is a member of New Hampshire Private Special Education Association and programs are accredited by the New Hampshire Department of Education.

Related Services—At the Monarch School of New England, speech-language, occupational, physical, vision, behavioral and nursing services are delivered using an integrated approach to support education and skill development. A variety of therapeutic programs are offered, including hippotherapy, aquatics therapy, and horticultural therapy. Our comprehensively trained nursing staff works closely with families and physicians to maintain student health while at school.

Pre-Vocation and Vocational Programs—Students of all ages participate in what is now called Work-Based Learning, progressing from jobs in school to jobs in the community. Instruction is currently offered in culinary, hospitality, retail, technology, woodworking/trades and horticultural/garden industries. Our vocational program aligns with the *New Hampshire Department of Education Career Development Framework*, the *Individuals with Disabilities Education Act*, and guidelines established by the New Hampshire Department of Labor's *School-to-Work Program*.

Collaborative Team—The Monarch School of New England's reputation for excellence enables the school to serve as a resource to other school teams. The Collaborative Team works with school districts to provide support to students with significant disabilities who stay in their home school.
